**Community Based Centers**

**These Centers provide for basic needs of orphans and widows through feeding programs, but also focus on community development programs with long-term sustainability. Six centers operate in the rural areas outside of Lilongwe, the capital city in central Malawi. Programs are community based: operated by Ministry of Hope, Malawi (a Malawi-based NGO) in conjunction with village leadership and volunteers. Food is raised at the centers, supplemented by additional purchases as needed. Increasing emphasis is on development programs, such as Village Saving and Loan Associations and income generating projects that will allow the community to provide for their own members.**

**Education Scholarship Program for high school, college and tradeschool Higher education allows children to escape the cycle of poverty, help their families and communities, and strengthen the national economy. Scholarships go to the best and brightest, hardworking and successful students. This in turn inspires other children to work hard in school.**

**Crisis Nurseries for Orphans.**

**Two Crisis Nurseries are operated and are providing residential care for orphaned and vulnerable infants. Many of the children are born of HIV/AIDS positive mothers and have been orphaned at birth. The children are nursed back to health and returned to their extended families or new, adopted families. One nursery is in the capital city of Lilongwe, Malawi and the other is in the north, in Mzuzu, Malawi.**
